[Tokyo Stock Exchange - TOKSE:4114.T] ("NIPPON SHOKUBAI") hereby announces that NIPPON SHOKUBAI executed the acquisition of its own shares in the market based on Article 156 of the Corporation Law of Japan as modified by the provision of 165(3) of the same law. NIPPON SHOKUBAI also announces that it completed acquisition of its own shares in the market, which was resolved by its Board of Directors on June 19, 2008.
