
Nippon Shokubai reorganize Energy & Electronics Solutions Division, Innovation & Business Development Division, etc. mainly for the following reasons.

Major Newly Established Organizations and Their Overviews

<Divisions>

In order to further accelerate and promote the expansion of the battery materials business, "Battery Business Solutions" will be newly established. This division will consist of three departments: sales & marketing, research, and technology development.



Establish "IONEL Project Planning Department" in the Business Planning Division to realize and promote global development of the IONEL business through collaboration with other companies, etc.




Establish "Water & Environment Solutions Business Department" to accelerate the commercialization of the water and environmental business. This department will have business planning and R&D functions.

Establish "DX Promotion Department" at Kawasaki Plant to accelerate smart factory and DX promotion.

<Group>

To promote the acquisition of new evaluation technologies that will contribute to strengthening the Solutions business, "Materials Evaluation and Analysis Research Center" will be reorganized into two groups.

"Intelligence Group" will be newly established in "Intellectual Property Center", comprising three groups, in order to strengthen the ability to analyze intellectual property information.
