Report on the Investigation Results Regarding Unauthorized Access to Our Server

NIPPON SHOKUBAI CO., LTD. (the “Company”) hereby announces that we confirmed a part of our group’s servers were subject to unauthorized access by a third party as we announced in our previous release dated May 30, 2025, titled "Notice Regarding Unauthorized Access to Our Server". We have now completed a thorough investigation conducted by external experts as well as our internal team. We hereby report the results of the investigation and the measures we are implementing to prevent recurrence. We sincerely apologize for the inconvenience and concern caused to our business partners and all other related parties.

**1. Investigation Results**

Following the confirmation on May 27, 2025, that unauthorized access had occurred to a part of our group’s servers, we conducted a detailed investigation in collaboration with external experts to determine the cause and assess the extent of the damage.

As a result, we identified traces of unauthorized access by a third party to multiple file servers and confirmed the possibility that certain personal information may have been leaked externally. Upon identifying this incident, we promptly reported it to the Personal Information Protection Commission.

No unauthorized access was detected in any business systems other than the affected file servers.

Furthermore, from the time the incident was identified to the present, we have not confirmed any actual leakage of personal information related to this matter, nor have we identified any secondary damage resulting from such leakage.

**2. Measures to Prevent Recurrence**

Based on the results of the investigation, we have already strengthened our monitoring systems, including the expansion of unauthorized access detection sensors.

Going forward, we will continue to work with external experts to further enhance our security measures and monitoring systems and remain committed to preventing recurrence.

### **3. Impact on Financial Results**

At present, there is no revision to our earnings forecast as a result of this incident. Should any matters requiring disclosure arise in the future, we will promptly make an announcement.
